The Red Cloud Community Schools Board of Education held their regular monthly board meeting on Monday, November 20, 2023 in the Library at the Red Cloud Elementary School. President Armstrong called the meeting to order at 7:00 p.m. with members Armstrong, Hobbs, Horne, Ord, Peterson, and VanWey answering roll.

Mrs. Dallman, Elementary Principal, reported that a Teaching and Learning Conference was held in Hastings. She also had an online Autism Conference and an online meeting about dyslexia. She reported that Preschool had their Stone Soup Event with 88% participation. Upcoming activities include a Leadership Rounds training, an 1184 meeting, and a Music Concert on December 7.
